

# **PRIVACY POLICY**

## 1. CONFIDENTIALITY DECLARATION

1.1. This Confidentiality Declaration pertains to Capinex Capital Ltd, an international brokerage and clearinghouse, licensed under number BFX2024013, with its headquarters located at 1257 Bonovo Road, Fomboni, Comoros Union. The purpose of this statement is to safeguard the personal and financial information of our clients and website visitors, which we regard with the highest priority. This Privacy Statement details the procedures by which we collect, use, and protect your information.
